The reason that safety is important is because our families, friends, and co-workers as they do not expect us to come home with an injury or illness from our jobs. This effects children, moms, dads, brothers, sisters, aunts, uncles, and friends.

When I had the position of a regional manager I had a safely supervisor that was reporting to me. This person's responsibility was to oversee, train, and advise on the corporate health and well being of the organizations safety program. I can assure you that there are compelling reasons in the corporate manual that states that the breaking of a safety rule has consequences including termination. Most companies take safety this serious and you need to likewise take it seriously.

Take a journey with me as the final reason safety is matter of life and death. A young man who worked for the railroad was performing some work on 100 foot tower. One of the safety rules state that you must me tied off at all times when climbing poles or towers. This young man was tied off; however, he was tied off to a steel tower member that he was removing and fell 90 feet. He lived 4 and half days, but his internal injuries were massive. Safety is personal. Safety only works because of Work Ethics.

The "how" is simple. Make sure you read your company safety manual. Make sure you stay focused on the job and make safely important for you, your coworkers, and your family. Not only is this important for staying employed it could be a life and death matter.
